## **Approval and Conformity Review**

The Planning Commission will hold a Work Session to consider an Applicant's request for an extension of the approval for the Preliminary Subdivision Plan for The Villages at Swan Point, XPN 07-0010. If granted, this request will extend the approval to August 5, 2028, which is the maximum extension that this Preliminary Subdivision Plan is eligible for. This request required a Conformity Review and an updated Traffic Impact Study to ensure the plan meets the current applicable regulations.

The Planning Commission originally considered this application during a Public Meeting held on September 15, 2025. They deferred their decision and extended the public comment period until 4:30 p.m. on Tuesday, September 30, 2025.
